

# **COVID-19 Weekly Update- Employee (For January 8-14, 2022)**



## College COVID-19 Status (January 1,2022 through 10:00 am Friday, January 14, 2022)

- <u>46</u> reports (includes positive cases, symptomatic individuals, close contacts, and potential exposures)- +16 from last update
- 18 confirmed positive cases- +9 from last update
- <u>29</u> individual(s) are currently in isolation or quarantine either on- or off-campus

## Garrett County COVID-19 Status (January 1, 2022 through 10:00 am Friday, January 14, 2022)

- Level of Community Transmission- High [no change from last update]
- Case rate of 142.1 per 100,000 [increased from last update]
- Positivity Rate of 20.3% (state rate is 24.77%) [county increased, state decreased from last update]
- Percentage of population (12+) fully vaccinated is 53.8%



## **Current News**

- New testing facility is slated to be opened at Garrett Regional Medical Center in Oakland by the end of next week. 7-day/week testing will be available.
- KN95/N95 masks are being recommended for use instead of cloth masks. <u>Are N95 and KN95</u> masks reusable and how should you store them? (msn.com)
- The Supreme Court has blocked the OSHA ETS vaccination mandate. Employees are still strongly
  encouraged to get vaccinated and boosted.

#### **Quarantine and Isolation Protocols**

For the health and safety of the campus community, Garrett College will continue with the extended isolation and quarantine guidance, despite the shortened quarantine and isolation period recently published by the Centers for Disease Control and Prevention (CDC). The protocols are as follows:

- Isolation
  - o Test positive, isolate for at least 10 days.
  - o Can return after 10 days if no fever for 24-hours and other symptoms have improved.
- Quarantine for exposure/close contact
  - If vaccinated and boosted- not required to quarantine unless symptomatic. Should test
     5-7 days after exposure
  - Not boosted or unvaccinated- quarantine for at least 7-10 days unless symptomatic.
     Should test 5-7 days after exposure
  - Previous infection within 90-day period- depends on when last tested positive in that timeframe. Most likely will be required to quarantine and follow guidance above for not boosted or unvaccinated

#### **Health and Safety Protocol Reminders:**

- Masks/face coverings are required to be properly worn in all indoor locations (which includes common areas of the residence halls).
- Social distancing of 3 feet is strongly recommended in crowded indoor and outdoor settings.
- **STAY HOME** when you are sick, awaiting test results, or have been identified as a close contact, until you have been cleared to return to campus.
